No late submissions, emailed or faxed documents will be accepted.

The following Pre-qualifying conditions will be applied to all bids:

- Only level 1 & 2 B-BBEE companies will be considered.

A tenderer that fails to meet the above pre-qualifying criteria will be viewed as an unacceptable tender.

### EVALUATION CRITERIA FOR THIS BID

Bids will be evaluated according to the Kgatelopele Local Municipality's Supply Chain Management Policy, Preferential Procurement Policy Framework Act (Act 5 of 2005) and the Preferential Procurement Regulations, 2017, and Broad Base Black Economic Empowerment Act (Act 53 of 2003).

The minimum threshold for functionality will be 60 points, where all individual thresholds are adhered to. Any bid that fails to meet the minimum threshold (as well as individual minimum components) will not be evaluated further.

The evaluation criteria, score and weightings for measuring functionality are shown on the table below for panel of contractors and consultants.

- Personnel Qualifications (team leaders & proposed team)
- Relevant previous experience of the company in the stream of specialisation in the past 5 years
- Bank rating
- Locality
- ISO:9001 – Quality Management System (for consultants only)

Please note that it is a prerequisite of the Municipality that all service providers are to be registered on the **National Treasury Central Supplier Database (CSD)**. The submissions of valid and up to date SARS tax clearance certificates are compulsory and municipal rates accounts. Registration on CSD can be done at [www.csd.gov.za](http://www.csd.gov.za) or at your nearest Treasury office and Kgatelopele Municipal Offices.

The Municipality reserves the right to withdraw any invitation to tender and/or to re-advertise or to reject any tender or to accept a part of it. The Municipality does not bind itself to accepting the lowest tender or award a contract to the bidder scoring the highest number of points.
